ANNOUNCEMENT: - Huddersfield Falcons MCC will organise a Centre Restricted Trial on Sunday 18th May 2014 for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting. This event will be a round of the West Yorkshire Group Championship as well as the 5th. Round of the Huddersfield Falcon Club Championship.

ELIGIBILITY: - Restricted to registered members of Clubs affiliated to Yorkshire Centre ACU. Participants must hold a current ACU Trials Registration Card or SACU license. Other riders must produce a license and start permission confirming insurance from their FMN. These must be available for inspection on request.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

CLASSES: -Championship Route: - Expert, Intermediate, Novice and Youth A

Clubman A Route: - Over 45 Experts, Over 45 Intermediate, Novice and Youth B

Clubman B Route: - Novice and Youth C

Any class of rider may choose to ride another route on a no-points basis.

Separate Club Championship Classes for Over 40's, Pre-65 and Twinshock will run concurrently

AWARDS: -Best Performance on Main Course. The Brian Clarkson Trophy* + Replica Award

1st, 2nd, and 3rd in each class on each course – an award. (Subject to at least 3 entries in each class)

*(Trophy to be held for one year only).

Points for the Club Championship are awarded for finishing positions in each class for each event. Overall class winners will be decided on the best nine of ten rounds with a minimum number of six rounds required to count.

NB. ALL MAIN AWARDS TO BE MADE AT THE YEAR END FALCON MCC DINNER & AWARDS EVENING IN EARLY 2015.

COURSE: - All on private land, to consist of 3 laps of 14 sections of a CHAMPIONSHIP, CLUBMAN A & CLUBMAN B course.

The White / Dead Easy Route will be a maximum of 10 sections.

Sections shall be ridden in correct order on each lap. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

Actual number of sections and laps will be confirmed on the day along with the method of closure or time limit.

METHOD of MARKING: - As per TSR 22b (No Stop). Ties will be resolved as per TSR 23

PROTESTS: - as per the National Sporting Code of the ACU, section 10.04
