ANNOUNCEMENT: - Huddersfield Falcon MCC will promote a Club Restricted Trial on 26/06/19 for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting.

ELIGIBILITY: - Restricted to registered members of Huddersfield Falcon MCC. All riders and passengers must hold a current ACU Trials Registration/Membership card or a SACU licence or ACU / SACU rider's license. Any rider or passenger from another FMN must produce a Licence issued by their FMN together with start permission and proof of personal accident insurance. These must be available for inspection on request.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

CLASSES: Novices, Beginners, T/Shock, O40's, Pre. 65 and Youth A, B, C & D.
There will be 3 courses to choose from – Hard, Clubman A (50/50), Clubman B (Easy)

START / VENUE: - 6.30 pm. at HORN HILL, NEW MILL, HOLMFIRTH, near HUDDERSFIELD, HD9 7DH –
off A635 near Crossroads PH (O/S Map Ref 110/174086

No engines to be run before start time or until instructed.

ENTRIES / FEE: Entries must be on the completed Club's Standard entry form appended to these Regulations (or available to download from the website), along with the ENTRY FEE OF £10 PER RIDER (£5.00 aged 16 and under), plus Falcon Club membership of £5 for 2019 if not already paid, and should be submitted to the TRIAL SECRETARY up to 1 hour before Start.

CHEQUES PAYABLE TO HUDDERSFIELD FALCON MCC PLEASE.

RESULTS: - Will be published on our web site - www.falconmcc.co.uk Please include a SAE if you require posted results.

AWARDS: Overall winner of this 3 Round Evening Series will be awarded the Wilf & Peggy Holland Summer Wine Trophy, and each Class winner will also receive an Award, subject to there being at least 3 competitors in each class - AWARDS TO BE MADE AT THE YEAR END FALCON MCC DINNER & AWARDS EVENING IN EARLY 2020.

COURSE: - All on private land and will generally be a minimum of 3 laps of eight sections (to be decided on the day). There will be 3 courses to choose from – **Hard, 50/50, Easy**, with a course-closing time of 9.00pm at the latest.
Sections shall be ridden in correct order on each lap. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

METHOD of MARKING: - As per TSR 22b; stop NOT permitted. Ties will be resolved as per TSR 23. Failure to attempt a section will incur a 10 mark penalty in accordance with ACU Rules; alternatively you can incur a 5 mark penalty, but only if you request this off the Observer rather than attempt the section – this ruling applies to closed-to-club trials only. To be classified as a finisher riders must attempt at least 75% of the sections.

PROTESTS: - as per the National Sporting Code of the ACU section 10.04.

- ACU Licences and Club Membership Cards must be available for inspection on request.
